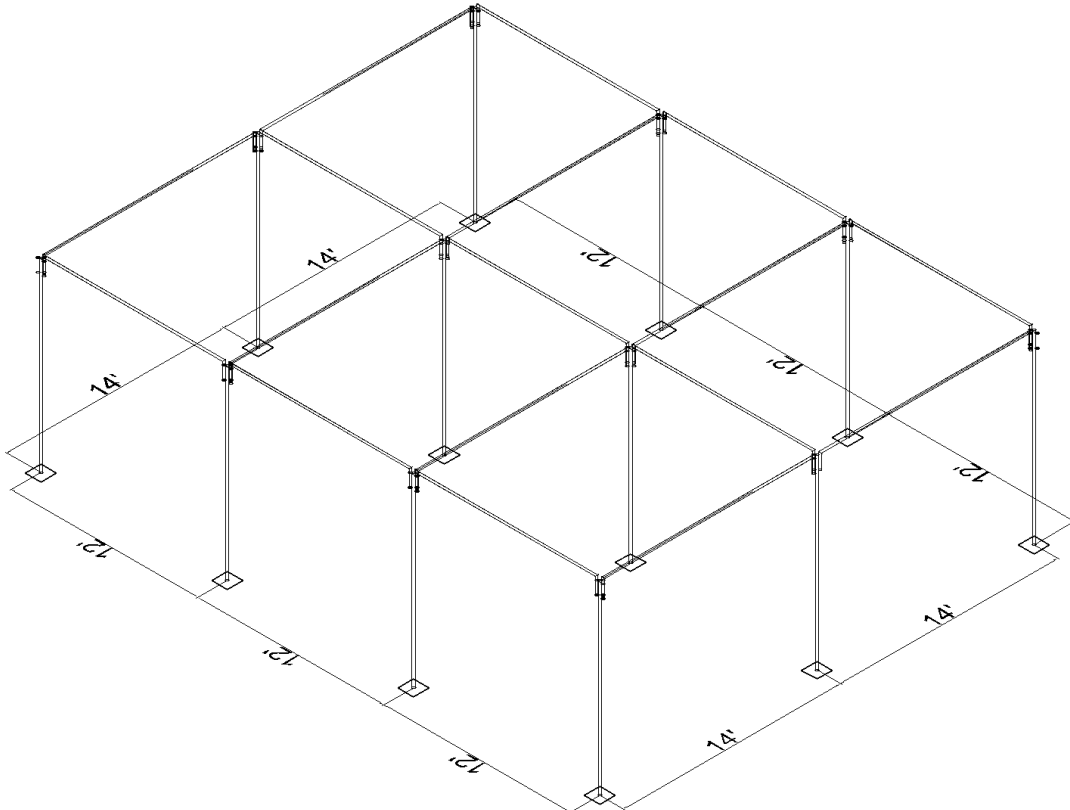
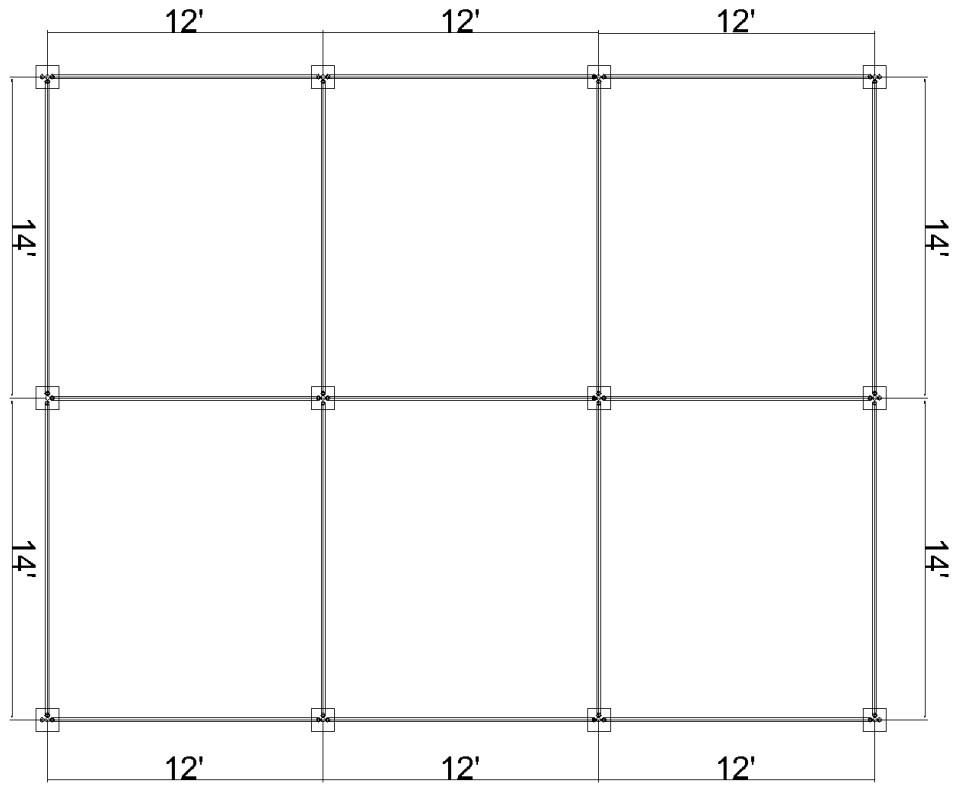

3. The EMD is liable to be forfeited in full if the bidders fail to start the work after award or withdrawal of offer before award of the work, the EMD is liable to be forfeited.
4. The Bidder should have valid **GST registration no.** of concerned Govt. Authorities
5. The rates shall be inclusive of all taxes, transportation & any other charges/arrangement of electricity/water etc. and apply to all heights; floors, leads and nothing extra shall be paid.
6. The Contractor / Bidder / Party have to **submit GST invoice** for payment of each running or final bill with proper abstract and MB as per the agreed rate in the Schedule of Rate.
7. The department shall not be responsible for any accident and theft before handing over and completion of work.
8. The department can close the work order at any time without any notice.
9. Security Deposit shall be deducted @2.5% of the gross amount of each running & final bill. The Security Deposit shall not be refunded before the expiry of 6 months after the issue of the certificate final or otherwise of completion of work, or till the final bill has been prepared and passed whichever is later.
10. Any damage/mis happenings/legal proceeding/ compensation occurred during the execution of the contract shall be borne by the agency and department shall not be responsible for any such occurrence.
