2. Eligibility Criteria

- a) The Bidder's Firm should have existence for minimum period of 3 years. (Copy of Certificate of Incorporation/ Registration Certificate of the Firm to be submitted). The OEM or its authorized dealer can participate in the above tender.
- b) Copy of the PAN card / GST of the firm.

- c) Copy of the IEC Code certificate (if applicable).
- d) The Bidder must not be blacklisted/suspended or any service related dispute with any Organization / Govt. Organization in India or outside. A declaration to that affect has to be given as per attached format at **Annexure -II**.
- e) Client Details- The Bidder should have history of supplying similar items as mentioned in Annexure 1 to CSIR Labs / ICMR Labs / ICAR Labs / IISER/ IIT Labs/NIT Labs / Central Universities / DRDO /CFTI/ Govt. Organization in the past three years. Copies of purchase orders / Rate contracts must be enclosed with the Offer.
- f) The Bidder should have an Annual Business turnover of Rupees 10 Lakh or more for the last 3 financial years (2023-24, 2024-25,2025-26) and shall enclose the audited balance sheet for proof of the same.
- g) The Bidder should have filed ITR for the last two financial years i.e., FY 2023-24, 2024-25, 2025-26 (Copies of the ITR acknowledgement to be submitted).
- h) If the Bidder is a Local Distributor/dealer/Stockiest, it is mandatory to attach Original Authorization Certificate along with the bid. **In the authorization certificate, the mail id of the OEM should be clearly mentioned for sending verification.** In case any document found incorrect or tampered then the bid will cancel.

- j) The bidders should have to submit an undertaking regarding Fall clause with the Director, IISER Berhampur as per **Annexure- "V"**.
- k) Quotation will be accepted only from manufacturers of branded items. If they are not in a position to quote, they **authorize only one exclusive agent** who may quote along with authorization. The authorization certificate format should be enclosed as per **Annexure- "VI"** failing which the quotation will be summarily rejected.
- l) The bidder i.e. OEM/ Distributer/ Dealer has to enclose the updated Product /Price list along with the bid.

1. Quotations will be accepted only from manufacturers or they may authorize **only one exclusive agent** against Tender Enquiry No IISERBpr/S&P/2025-26/08 Date March 24, 2026, who may quote along with authorization valid as on date of submission of bids. Authorized Agent quoting for the supply should attach authorization from the manufacturers on company's letter head, failing which the quotation will be summarily rejected.
2. The bid is to be submitted on-line on CPP portal. The Product Catalogue, CDs, Price List and Declaration regarding Clean track, Acceptance of tender terms and Conditions, under taking for fall clause, Original authorization letter on Manufacturer's letter head are to be submitted manually by Speed Post /Courier at the following address for our record on or before closing date

3. The Rate Contract will be valid for a minimum period of one year. The Prices offered shall be valid for a period from of 01 year with effective from issuance of work order. There will be no additional charges for Delivery. The Delivery will be FOR on Free of Cost basis. **The companies which cannot provide validity of rates for One Year and price list need not to apply.**
4. Bidders shall satisfy the requirements of a Class I Local supplier and Class II Local supplier issued in pursuance of „Make in India“ policy vide Order No. P- 45021/2/2017-PP (BE-II), dated 16th September, 2020 of Ministry of Commerce and Industry, Government of India, as amended from time to time. Bidder may please refer said order dated 16th September, 2020 for further details.
5. **Local Content:** „Local content“ means the amount of value added in India, which shall, unless otherwise prescribed by Nodal Ministry, be the total value of item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all custom duties) as a proportion of the total value, in percent.
 - (i) „Class - I Local supplier“ means a supplier or service provider, whose goods, services or works offered for procurement, meets the minimum local content as prescribed for „Class- I local supplier“ in the said order dated 16th September, 2020.
 - (ii) „Class- II Local supplier“ – means a supplier or service provider, whose goods, services or works offered for procurement, meets the minimum local content as prescribed for „Class- II local supplier“ but less than that prescribed for „Class-I local supplier“ under said order dated 16th September, 2020.
 - (iii) „Non – Local Supplier“ means a supplier or service provider, whose goods, services or works offered for procurement, has local content less than that prescribed for „Class-II local supplier“ under this Order.
 - (iv) Minimum local content: The „local content“ requirement to categorize a supplier as „Class-I local supplier“ is minimum 50% For „Class-II local supplier“, the „local content“ requirement is minimum 20%. Nodal Ministry/Department may prescribe only a higher percentage of minimum local content requirement to categorize a supplier as „Class-I local supplier“/„Class-II local supplier“. For the items, for which Nodal Ministry/Department has not prescribed higher minimum local content notification under the Order, it shall be 50% and 20% for „Class-I local supplier“/„Class-II local supplier“ respectively.

- (v) Note- Bidder is required to indicate percentage of local content and provide self-certification the items offered meet the local content requirement for „Class -I Local Supplier“ /“Class - II Local Supplier“ as the case may be. Further, the bidders shall also give details of the location(s) at which the local value addition is made. Only „Class -I Local Supplier“ /“Class - II Local Supplier“ as defined under said “Make in India” order dated 16.09.2020 shall be eligible to submit RC offers. Hence, offers from „Non - Local Supplier“ or products not complying with the requirement of Class I Local supplier and Class II Local supplier shall not be considered of issue of RC Contract.
- (vi) **Verification of local content:** The „Class-I local supplier“/“Class-II local supplier“ at the time of tender, bidding or solicitation shall be required to indicate percentage of local content and provide self- certification that the item offered meets the local content requirement for „Class-I local
- (vii) supplier“/“Class-II local supplier“, as the case may be. They shall also give details of the location(s) at which the local value addition is made.
6. The evaluation of the bids shall be done based on requirement of IISER Berhampur and any decision taken by the Institute into the matter will be final and binding.
7. The bids which are incomplete, not in conformity with the terms & conditions of the bid, conditional bids and unsigned bids shall be rejected as non- responsive without any further evaluation.
8. Bids not supported by the eligibility criteria, submission of declarations as per specified formats shall be summarily rejected.
9. Bidders may be called for discussion /clarification/ further discount before the finalization of rate contract, if considered necessary by IISER Berhampur.
10. All the bids where the maximum discount on Net Dealer Price (NDP) /Price List is offered shall be processed for finalization of the rate contract.
11. Prices must be quoted on the basis of Discount on Net Dealer Price(NDP) for each category of items in terms of Percentage (%) discount on NDP. Additional Dealer Discount may also be mentioned clearly wherever applicable.
12. The bidder must undertake that the prices mentioned in their pricelist are firm and valid till end of the Rate Contract (RC) period without any hike. However, in the event of any decrease in the prices during the contract period the same should be notified to IISER Berhampur. Besides this, if any special promotional marketing scheme(s) is/are launched from time to time, the same must be made available/ intimated to the Institute.
13. The bidder should ensure that the prices quoted are FOR, IISER Berhampur basis including its unloading at Institute premises and delivery till the laboratory as per the details given in the Institute Purchase Order (PO) and inclusive of all taxes and duties. In case of temperature-controlled products, necessary precautionary measures shall be taken so by the supplier such that the item(s) remain in the specified temperature till its delivery to the IISER Berhampur end user.
14. The prices remain fixed during the currency of the RC and the end users of the Institute shall be invariably offered agreed benefits of the Rate Contract item(s) in all orders of purchase by IISER Berhampur, in view of any urgency. In such cases, the bidder is not permitted to charge higher prices than the prices approved by the Institute under the RC. Incase if it is found that the bidder is charging lesser prices than the prices agreed under the rate contract to any other organization

/ user, the RC prices/ orders shall be modified suitably without any intimation to the bidder.

15. The period of rate contract will be for one year. However, in special case reserves the right to extend or curtail the period of Rate Contract.
16. The Bids should be complete in all respects and should be duly signed. Incomplete and unsigned bids will not be considered.
17. There shall be no change in price structure during the currency of contract except of the statutory levies which are made applicable by the Govt. through notifications and regulations. However, the Bidder will pass on the advantage to in case of downward price movement during the Contract period.
18. List of Other Similar Organizations where similar supplies have been made and having a Rate Contract may be submitted.
19. Prices charged for the stores supplied under Rate Contract should under no event be higher than lowest prices at which the party sells the items to any other organization during the period of contract.
20. **The rate contract will be guided by “Fall Clause”.**
“if the rate contract holder reduces its price or sells or even offers to sell the rate contracted goods following conditions of sale similar to those of the rate contract, at a price lower than the rate contract price, to any person or organization during the currency of the rate contract, the rate contract price will be automatically reduced with effect from the date for all the subsequent supplies under the rate contract and the rate contract amended accordingly,”
21. If the supplier fails to deliver the material within the delivery period as specified, IISER Berhampur may procure goods or services similar to those undelivered upon such terms and in such manner as it deems appropriate from any other firm and the supplier will be liable to the purchase for any excess cost. The supplier will be liable to the IISER Berhampur for any excess costs incurred for procurement of goods or services not delivered in time.
22. The items, so supplied will have to be of high quality and grade and in the inspection/test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the Rate Contract of the firm may be cancelled. Delayed supply/non-compliance of complete order may also lead to cancellation of Contract.
23. **Liquidated Damages:** The date of delivery should be strictly adhered to; otherwise the IISER Berhampur reserves the right not to accept the delivery in part or full. The liquidated damages @0.5% per week subject to a maximum of 10% of the value of the order can be imposed.
24. **Warranty** – The tenderer shall be fully responsible for the manufacturer warranty in respect of quality and workmanship of the materials covered in the Rate Contract. In case of any defects found at the time of use, the supplier will provide free replacement or refund the amount charged for that item.
25. **Payment Terms** – Our Payment terms are normally within 30 days of receipt and acceptance of goods at IISER Berhampur. Payment will be made by NEFT. No Advance Payment will be made under any circumstances.
26. IISER Berhampur is entitled to place orders up to the last day of the validity of the rate contract and, though supplies against such purchase orders will be effected beyond the validity period of the rate contract, all such supplies will be guided by the terms and conditions of the rate contract.
27. IISER Berhampur will not be liable for any obligation or supplies made unless the Official Purchase Order has been placed by the Purchase Department.

28. The firms are entitled to withdraw/cancel the rate contract by serving one-month notice on each other. However, once a purchase order is placed on the supplier for supply of a definite quantity in terms of the rate contract during the validity of the rate contract, that purchase order becomes a valid and binding contract.
29. IISER Berhampur does not guarantee or assure of any quantum of business during the contract period. The order will be issued only if the requirement of such items arise in the Institute.
30. All disputes of any kind arising out in connection with the executing the order shall be referred by either party (IISER, Berhampur the bidder) after issuance of 30 days" notice in writing to the other party clearly mentioning the nature of dispute to a single arbitrator acceptable to both the parties. The venue for arbitration shall be IISER, Berhampur, India. The jurisdiction of the courts shall be Berhampur, Odisha, India.
31. Normally, no condition of the tender shall be relaxed. However, the Director, IISER Berhampur may relax any of the conditions of the tender in the best interest of the Institute in exceptional cases depending upon the merits of the case. The Director, IISER Berhampur reserves the right to accept or reject any offer in part or in full without assigning any reasons thereof.
32. Delivery period: 20 days from the issuance of the purchase order. The delivery location will be either at Transit/ Permanent campus of the institute.

33. Bid Validity Period:

- (a) The prices must be valid at least for a period of 120 days from the date of opening of the Tender. No changes in prices will be acceptable in any condition after opening of tender till the validity of the offer or execution of the order whichever is later
- (b) Bid evaluation will be based on the bid prices without taking into consideration the above corrections.

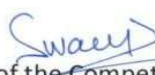

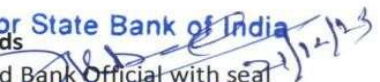
